2015 – 2016 BUS SERVICE REGISTRATION INFORMATION

Dear Parent or Guardian,

Registration for the John Carroll Catholic High School Bus Service for the 2015 – 2016 School Year is now taking place. The Bus Service serves students (K – 12) from John Carroll Catholic High School and St. Anastasia School. The Bus Service covers the geographical area from Ft. Pierce to Port St. Lucie where it is possible. It is intended to serve as a shuttle service with a limited number of seats and stops. Every year the bus route will change to adapt to those students who have registered for bus service. Riders are registered on first come, first served basis. **Bus Service DOES NOT guarantee to meet the demands of all students.**

The cost for the Bus Service for the 2015/2016 school year is \$2000.00. This amount includes a \$200.00 registration charge of which \$100.00 is non-refundable. You may pay in 10 monthly installments, beginning in August and going through May. Your first payment will be \$200.00, which should include your Registration Form. After that, the monthly fee is \$200.00. To make **your payments you will need to contact Mrs. Carter in bookkeeping. (kcarter@johncarrollhigh.com)**

All outstanding balances owed to the Bus Service must be paid prior to registration for the new school year. Registrations will be processed only when accompanied by the correct amount due. All refunds must be requested by the first two weeks of school.

Please return your registration form as early as possible. You may send it with your child to hand to me on bus the first time the student rides. You may contact me (second week in August) by way of email or cell phone listed below for bus stops and times. Bus stops will be established beginning August 1, 2015. Riders registering after that time are not guaranteed a bus stop or a seat.

It is the responsibility of the parents to maintain their bus account. If payment is not made for two consecutive months, the bus riders will be suspended until all past due payments are paid.

BUS SERVICE CONTRACT

CONDITIONS:

- 1) REGISTRATION IS DUE AUGUST 15, 2014. REGISTRATIONS WILL NOT BE ACCEPTED WITHOUT ALL OF THE ABOVE INFORMATION AND THE REQUIRED \$200.00 PER STUDENT (REGISTRATION FEE AND FIRST MONTH SERVICE CHARGE). ALL PREVIOUS CHARGES MUST BE PAID PRIOR TO REGISTRATION.
- 2) BUS FEES NOT PAID FOR 2 CONSECUTIVE MONTHS WILL SUSPEND SERVICE. ACCOUNTS MUST BE CURRENT AT ALL TIMES.
- 3) CANCELLATION OF SERVICE MUST BE IN WRITING NO LATER THAN SEPTEMBER 4, 2015 OR YOU WILL BE RESPONSIBLE FOR BUS FEES THROUGH DECEMBER, 2015.
- 4) IF YOU WITHDRAW YOUR STUDENT(S) FROM HIS/HER RESPECTIVE SCHOOL AFTER 8/31/15 OR 1/31/16, THEN YOU WILL BE RESPONSIBLE FOR THE BUS FEES FOR THE REMAINDER OF THE FALL OR SPRING SEMESTER.
